CONVEYANCE ALLOWANCE CLAIM FORM

Effective September 2013

Information required to complete a Conveyance Allowance Claim Form

- Parents/carers must provide complete and accurate information on their Conveyance Allowance Claim Forms
- Distance provided by parent/carers must be accurate to within 100 metres (ie 0.1 km) and must be measured along the shortest practical road route.
- Parents/carers must submit a new application form for Transport Assistance if the student's circumstances change (eg if they change their residence, school, frequency of attendance at school, distance travelled or medical conditions).
- A parent/carer must submit a Change of Details form if the changes relate to their Bank Details, Contact Details or Alternative Contact Details.

Only Applicable to Mainstream Students

- To be entitled to a Conveyance Allowance, the student must reside more than 4.5km from their nearest appropriate school and more than 2.5km from the nearest appropriate bus route, as measured from the home gate of the student's residence
- If an appropriate bus service is available, a
 Conveyance Allowance will only be paid for travel to
 the nearest bus pick/drop-off location.
- The student is travelling to a bus service and the bus route is modified so that it comes within 2.5km of the student's residence

Payment of the Conveyance Allowance

- Parent/carer must complete a Conveyance
 Allowance Claim form and submit it at the end of
 each school term.
- The commencement date from which the Conveyance Allowance will be paid is subject to approval by School Bus Services (SBS).
- No Conveyance Allowance payment will be made for a period prior to the date of approval.
- Only one Conveyance Allowance payment will be paid per a family of eligible students.
- Conveyance Allowance payments are made in arrears as a lump sum at the end of each school term.
- Conveyance Allowance payments are made by electronic funds transfer into a bank account nominated by the parent/carer.
- Should an overpayment of a Conveyance Allowance occur for any reason, SBS will recover the amount that was overpaid.
- Conveyance Allowance claims will be audited by SBS on a regular basis.

Entitlement to a Conveyance may be withdraw if:

 Information provided by a parent/ carer on their Conveyance Allowance Application Form is false or misleading
